

## Information Sheet on Day School and Full-Day School

Schule Schloss Salem is operated as a boarding school for pedagogical reasons, but is prepared in principle to accept students and full-day students who live with their parents in the surrounding area. Due to the limited number of places available, admission procedures are also conducted for students and full-day students.

Salem is a non-profit organisation. While subsidies from the government cover a certain portion of expenditures for tuition (as established in Baden-Württemberg's Private Schools Act), the school must meet all remaining expenditures through fees paid by parents.

The fee charged to parents of **students** covers only the costs of classroom instruction equivalent in scope to regular state-run schools. As of 1 August 2018 Baden-Württemberg, mandates that private schools charge no more than 160 € per month for classroom tuition (§§ 5 VV-PsChG). This fee is exclusively for classroom instruction; additional fees for special or student-based services and activities (within the day school or boarding school) which are not mandatory for students and their parents are, however, permitted.

The non-mandatory fee for **full-day students** covers -- supplemental to the costs of tuition -- expenses for special student-based activities at school, morning snacks, lunch, and afternoon refreshments, expenses for full-day supervision, including extracurricular activities, clubs, community outreach service groups, and participation in handiwork and team sports activities.

The non-mandatory fee for **boarding school students** covers -- in extension of the costs for full-day students -- expenses for accommodations and full meal services as well as 24-hour pedagogical and medical care (see No. V of the General Terms and Conditions of Contract (GTC).

An **admission fee** which covers additional administrative costs is payable upon signing the Day School or Full-Day School Contract, if applicable an administration surcharge, along with a **security deposit** that will be refunded upon termination of the contract.
